GREETING A PROCLAMATION

WHEREAS in and by section 6 of Chapter 21 of the Acts passed by the Legislature of Prince Edward Island in the Third Session thereof held in the year 2012 and in the sixty-first year of Our Reign intituled "An Act to Amend the Registered Nurses Act" it is enacted as follows:

"This Act comes into force on a date that may be fixed by proclamation of the Lieutenant Governor in Council.",

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2012, c. 21 should come into force on the 19th day of November, 2016,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that the said Act being "An Act to Amend the Registered Nurses Act" passed in the sixty-first year of Our Reign shall come into force on the nineteenth day of November, two thousand and sixteen of which all persons concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and the Great Seal of Prince Edward Island to be hereunto affixed.

UNDER the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, the Prince Edward Island Potato Marketing Plan Regulations, and the *Agricultural Products Marketing Act* (Canada), the Prince Edward Island Potato Board makes the following order:

PACKAGING ORDER - AMENDMENT

Application

- This order is amended to provide regulations for the packaging of Canada No. 1 small potatoes, and the temporary utilization of paper bags in package sizes of 5 pounds or smaller for a two year trial period.
- 2. The following is added as Section 2.2.1 to Board Order PB98-1:

Suspension of

enforcement

(a) Enforcement of Section 2.2(a) is suspended for so long as this Section 2.2.1 remains in force;

Canada No. 1 Small

(b) No person shall market Canada No. 1 small potatoes (as graded in accordance with the *Canada Agricultural Products Act*, Stats. Can. 1988, Cap. 27) produced in Prince Edward Island unless such potatoes are washed and packaged in 5 pound, or smaller, polyethylene or paper bags, or in 50 pound bags or cartons for food service or institutional use only, with the grade of such potatoes printed thereon in such a fashion as to be incapable of removal or alteration;

Expiration

(c) This Section 2.2.1 shall expire and be of no further force on the 4th day of November, 2018.

Commencement

3. This order comes into force on the 4th day of November, 2016.

PUBLIC HEALTH ACT FOOD PREMISES REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated November 8, 2016.)

Pursuant to section 72 of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, Council made the following regulations:

- 1. The *Public Health Act* Food Premises Regulations (EC616/14) are amended by the addition of the following after section 24:
- **24.1** For the purpose of section 24, the Director may provide a food Director may hygiene training program and require a participant to pay a fee of \$50 for provide program this service.
- 2. These regulations come into force on November 19, 2016.

EXPLANATORY NOTES

SECTION 1 provides for the Director to offer a food hygiene training program for a fee of \$50.

SECTION 2 provides for the commencement of these regulations.

REGISTERED NURSES ACT NURSE PRACTITIONER REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated November 8, 2016.)

Pursuant to section 35 of the Registered Nurses Act R.S.P.E.I.1988, Cap. R-8.1, the Association of Registered Nurses of Prince Edward Island, with the approval of the Lieutenant Governor in Council, made the following regulations:

1. Section 5 of the Registered Nurses Act Nurse Practitioner Regulations (EC91/06) is revoked and the following substituted:

- Currency of practice 5. (1) For the purposes of clause 15(1)(b) of the Act, an applicant for a nurse practitioner's endorsement shall, within the three years immediately preceding the date of making the application, have
 - (a) successfully completed a recognized nurse practitioner education program; or
 - (b) lawfully practised as a nurse practitioner in Prince Edward Island or another jurisdiction recognized by the Council for a total of 1,800 hours.

No discipline or conduct review

(2) An applicant for a nurse practitioner's endorsement shall not, as of the date of application, be subject to a discipline or professional conduct review penalty or proceeding in any jurisdiction.

Examination: competence assessment

- (3) An applicant for a nurse practitioner's endorsement, other than an applicant referred to in subsection 15(1.1) of the Act, shall, where required by the Council, have successfully completed
 - (a) an examination approved by the Council;
 - (b) a competence assessment, approved by the Council, demonstrating competence to practise as a nurse practitioner; or
 - (c) the requirements in both clauses (a) and (b).

2. Clause 6(1)(c) of the regulations is revoked and the following substituted:

- (c) the ordering of, and interpreting reports of,
 - (i) doppler ultrasounds for deep vein thrombosis,
 - (ii) echo cardiograms, other than pediatric echo cardiograms, and
 - (iii) ultrasounds concerning the following areas of the body:
 - (A) abdomen,
 - (B) breast,
 - (C) lymph nodes for suspected adenopathy,
 - (D) pelvis,
 - (E) thyroid;

3. These regulations come into force on November 19, 2016.

EXPLANATORY NOTES

SECTION 1 amends the requirements for a nurse practitioner's endorsement to correspond with amendments made to the Act.

SECTION 2 revokes and substitutes a provision to permit nurse practitioners to order special types of ultrasounds and ultrasounds on additional areas of the body.

SECTION 3 provides for the commencement of these regulations.

REGISTERED NURSES ACT REGISTRATION AND LICENSING OF NURSES REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated November 8, 2016.)

Pursuant to section 35 of the *Registered Nurses Act* R.S.P.E.I. 1988, Cap. R-8.1, the Association of Registered Nurses of Prince Edward Island, with the approval of the Lieutenant Governor in Council, made the following regulations:

- 1. Section 1 of the *Registered Nurses Act* Registration and Licensing of Nurses Regulations (EC93/06) is amended
 - (a) in clause (d), by the deletion of the period at the end of the clause and the substitution of a semi-colon; and
 - (b) by the addition of the following after clause (d):
 - (e) "NCLEX-RN" means the National Council Licensure NCLEX-RN Examination for Registered Nurses developed by the United States National Council of State Boards of Nursing.
- 2. Section 6 of the regulations is revoked and the following substituted:
- **6.** (1) For the purposes of clause 13(1)(b) of the Act, an applicant for Examination registration shall, within three years of successfully completing the educational requirements in subclause 13(1)(a)(i) or (ii) of the Act,
 - (a) have passed
 - (i) on or after January 1, 1982, but before January 1, 2015, the CRNE or the NCLEX-RN, or
 - (ii) on or after January 1, 2015, the NCLEX-RN; or

(b) where the NCLEX-RN is not offered, have attained the minimum standard set for a substitute examination approved or adopted by the Council in accordance with subsection (2).

Substitute examination (2) Where the NCLEX-RN is not offered, the Council may approve or adopt, by resolution, a substitute examination and shall set a minimum standard that a person writing the substitute examination shall attain to pass it.

Currency of practice

- **6.1** (1) For the purposes of clause 13(1)(c) of the Act, an applicant for registration shall, within the five years immediately preceding the date the applicant submits a completed application form under clause 3(1)(a), have
 - (a) successfully completed the educational requirements in subclause 13(1)(a)(i) or (ii) of the Act; or
 - (b) lawfully practised and been employed as a registered nurse in a jurisdiction recognized by the Council for a total of at least 1,125 hours.

Alternative where lapse

(2) Where an applicant does not meet the currency of practice requirements in subsection (1), the applicant may demonstrate currency of knowledge and skills for the purposes of clause 13(1)(c) by passing the NCLEX-RN or, where the NCLEX-RN is not offered, a substitute examination approved or adopted by the Council in accordance with subsection 6(2).

Clarification of examination requirements

(3) For greater certainty, subsection (2) is in addition to and separate from the requirements in subsection 6(1).

Application for examination

6.2 (1) Where an applicant for registration does not meet the requirements of subsection 6(1) or 6.1(1), the applicant may apply in writing to the Registrar to take the NCLEX-RN or a substitute examination, if applicable, and the Registrar shall permit the applicant to take the examination, if the Registrar is satisfied that the applicant meets all other requirements and qualifications for registration set out in subsection 13(1) of the Act and in these regulations.

Examination results

(2) The Registrar shall notify an applicant for registration who writes the NCLEX-RN or a substitute examination, if applicable, of the results the applicant obtained on the examination as soon as possible after the results are known.

Required courses

- **6.3** (1) Subject to subsection (2), for the purposes of clause 13(1)(e) of the Act, an applicant for registration shall have successfully completed, at a school of nursing, the theoretical and clinical components of courses in the subject areas considered by the Council to be prerequisites for registration, including
 - (a) medical nursing;
 - (b) obstetrical nursing;
 - (c) paediatric nursing;

- (d) psychiatric nursing; and
- (e) surgical nursing.
- (2) An applicant referred to in subsection 13(1.1) of the Act is deemed Applicant with to meet the requirements of subsection (1).

extra-provincial certification

- 3. Clauses 19(1)(b) to (d) of the regulations are revoked and the following substituted:
 - (b) subsection 6.1(1) of these regulations;
 - (c) clause 13(1)(d) of the Act.
- 4. These regulations come into force on November 19, 2016

EXPLANATORY NOTES

SECTION 1 adds a definition of "NCLEX-RN".

SECTION 2 amends the requirements respecting courses and examinations for registration as a registered nurse to correspond with amendments made to the Act, to address the elimination of the CRNE and for clarification purposes. It also sets out the requirements respecting currency of practice for registration as a registered nurse to correspond with amendments made to the Act.

SECTION 3 amends provision references to correspond with amendments made to the Act and the regulations. It also removes the requirement for a permit that an applicant shall be registered as a nurse in another province, as this has been removed from the Act as a requirement for registration of applicants who completed their nursing education outside of the province. Also, labour mobility rules would apply to an applicant registered as a nurse in another province.

SECTION 4 provides for the commencement of these regulations.
