HIGHWAY TRAFFIC ACT DEMERIT POINT SYSTEM REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated November 27, 2018.)

Pursuant to section 284 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

- 1. Item 13 of the Schedule to the *Highway Traffic Act* Demerit Point System Regulations (EC1216/80) is amended by the deletion of the word "8" and the substitution of the word "12".
- 2. These regulations come into force on December 8, 2018.

EXPLANATORY NOTE

SECTION 1 amends the Schedule to provide that, where a person is convicted of contravening subsection 202(1) of the *Highway Traffic Act* by failing to stop for a school bus when the flashing red lights are displayed on the school bus, 12 demerit points will be entered on the person's driving record.

SECTION 2 provides for the commencement of these regulations.
