IN THE MATTER OF the Environmental Protection Act, R.S.P.E.I 1988, Cap E-9, Sections 3, 7, and 7.1 (herein "the Act")

ENVIRONMENTAL PROTECTION ORDER

TO: All persons, corporations, or governments owning coastal or riparian zone properties in Prince Edward Island and proposing to carry out new development in the Watercourse and/or Wetland boundary and its legislated buffer zone

WHEREAS in the last decade the Province of Prince Edward Island has seen a significant increase in coastal and riparian zone development into areas which are increasingly at risk from the impacts of climate change;

WHEREAS the rates of coastal and riparian zone erosion are expected to rise as climate change pushes up sea levels, expands average wave heights, and increases storm frequencies and intensities;

WHEREAS the installation and subsequent protection of coastal and riparian zone infrastructure may have negative impacts on the natural environment;

WHEREAS the placement of any residential, commercial, institutional, or municipal infrastructure, including shoreline protection measures in the watercourse and/or wetland boundary and legislated buffer zone is regulated under the *Environmental Protection Act* Watercourse and Wetland Protection Regulations;

AND WHEREAS I believe on reasonable and probable grounds that an act or omission of a person or corporation may be a threat to the environment and that it is necessary and advisable for the protection of the environment;

I THEREFORE ORDER, pursuant to sections 7 and 7.1 of the Act, the prohibition of any new residential, commercial, institutional, or municipal development in the legislated buffer zone and its associated erosion control activities in the watercourse and/or wetland boundary and legislated buffer zone by natural persons, corporations or municipalities owning coastal or riparian zone properties in Prince Edward Island.

This Order shall not apply to any Watercourse and Wetland and Buffer Zone Activity permits, or Watercourse, Wetland and Buffer Zone Activity Contractor Licensing Registrations, that were issued prior to December 1, 2022 from the Minister of the Department of Environment, Energy and Climate Action.

This Order shall not apply to residential, commercial, institutional, or municipal landowners who have existing critical infrastructure (e.g. dwelling, business, water/wastewater systems, septic system, etc.) and need to protect it from coastal or riparian zone erosion.

This Order shall not apply to residential, commercial, institutional, or municipal landowners who have had their existing erosion control structures damaged as a result of Hurricane Fiona and need them repaired.

This Order shall not apply to any Provincial Government Department on PEI which must install or maintain erosion control structures for the protection of public infrastructure, or must carry out work associated

with the repair, replacement or maintenance of wharfs, harbours, bridges, culverts and roads in the coastal and/or riparian zone.

This Order shall not apply to any Federal Government Department on PEI which must install or maintain erosion control structures for the protection of public infrastructure, or must carry out work associated with the repair, replacement or maintenance of wharfs, harbours, bridges, culverts and roads in the coastal and/ or riparian zone.

This Order shall not apply to any projects which receive a Provincial Environmental Impact Assessment (EIA) approval.

This Order shall cease to have effect on the date that a new coastal zone policy is adopted, unless sooner revoked by the Minister.

EC2023-52

LAND SURVEY ACT

SPATIAL REFERENCING REGULATIONS

(Approved by Her Honour the Lieutenant Governor in Council dated January 24, 2023.)

Pursuant to section 15 of the *Land Survey Act* R.S.P.E.I. 1988, Cap. L-2.2, Council made the following regulations:

1. Definitions

In these regulations,

- (a) "NAD83" means North American Datum of 1983;
- (b) "CSRS" means the Canadian Spatial Reference System;
- (c) "CBN" means the Canadian Base Network;
- (d) "CGVD" means the Canadian Geodetic Vertical Datum.

2. Schedule adopted

The Schedule to these regulations is adopted and forms part of these regulations.

3. PEI Coordinate System

The Prince Edward Island Coordinate System shall be that set out in Part I of the Schedule.

4. Vertical Reference System

The Vertical Reference System for the purposes of the Prince Edward Island Coordinate System shall be that set out in Part II of the Schedule.

5. Commencement

These regulations come into force on February 4, 2023.

SCHEDULE

PART I - PRINCE EDWARD ISLAND COORDINATE SYSTEM

Coordinate system defined

1. The Prince Edward Island Plane Rectangular Coordinate Projection is a stereographic double projection of the NAD83 (CSRS) geocentric ellipsoid, on a secant plane. The North American Datum of 1983 has been redefined through the Canadian Spatial Reference System (CSRS). It will be identified as NAD83 (CSRS). The dimensions of the NAD83 (CSRS) ellipsoid are as follows:

Semi-major axis (Equatorial Radius) = 6,378,137.0000 metres

Semi-minor axis (Polar Semi-diameter) = 6,356,752.3141 metres

2. The datum in Prince Edward Island is defined in terms of the values of the Canadian Base Network (CBN) stations determined from version 6.0 (2010) of the Canadian adjustment prepared by the Geodetic Survey Division of Natural Resources Canada. The values for the two Prince Edward Island CBN stations are listed as follows:

3. The true origin of the Prince Edward Island Coordinate System is a point at

Latitude: 47°15' North Longitude: 63°00' West

as defined by the NAD83 (CSRS) ellipsoid. The Y axis (North Axis) is the Geodetic Meridian through the origin, and the X axis (East Axis) is the straight line through the origin perpendicular to the Y axis. The scale factor at the origin is 0.999912 and the Gaussian mean radius of the projection sphere at the origin is 6,379,782.0995 metres. Coordinates are considered positive to the East and to the North. To avoid negative values, the origin has been given the coordinates

Y (North Axis) = 800,000 metres X (East Axis) = 400,000 metres

4. The position of a point shall be defined by two expressions, each given in metres and decimals of a metre. The first expression, to be known as the X coordinate minus 400,000 metres, shall indicate the perpendicular distance from the Y axis. When the distance is positive, the point is east of the origin; and when the distance is negative, the point is west of the origin. The second expression, to be known as the Y coordinate minus 800,000 metres, shall indicate the perpendicular distance from the X axis. When the distance is

positive, the point is north of the origin; and when the distance is negative, the point is south of the origin.

- 5. The coordinates shall be made to depend upon
- (a) the values of the two Prince Edward Island CBN stations set out in this Part; or
- (b) the values of the densification of the CBN carried out by the Department of Transportation and Infrastructure for the purpose of establishing the Prince Edward Island Active Control Network.

PART II - VERTICAL REFERENCE SYSTEM

Canadian Geodetic Vertical Datum of 2013

1. The Canadian Geodetic Vertical Datum of 2013 (CGVD2013) is the official datum of Prince Edward Island and replaces the Canadian Geodetic Vertical Datum of 1928 (CGVD28).

CGVD2013 defined

2. CGVD2013 is a gravimetric datum defined by the equipotential surface $w_{\text{o}}=62,\!636,\!856.0~\text{m}^2\text{s}^{\text{-}2},$ representing the average potential of coastal mean sea level at tide gauges across North America. The definition and geopotential value come from an agreement between Canada and USA. Heights in terms of CGVD2013 are in the orthometric height system.

ROADS ACT

VEHICLE WEIGHTS AND DIMENSIONS REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated January 24, 2023.)

Pursuant to section 55 of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

- 1. Section 1 of the *Roads Act* Vehicle Weights and Dimensions Regulations (EC1/02) is amended
 - (a) by the addition of the following after clause (b):
 - (b.1) "aerodynamic device" means auxiliary equipment that is designed and used to improve the aerodynamic performance of a vehicle and is mounted at the rear of a truck, trailer or semi-trailer;
 - (b) by the addition of the following after clause (e):
 - (e.1) "auxiliary equipment" means equipment that
 - (i) is permanently mounted at the front, rear or sides of a vehicle, and
 - (ii) is not designed, intended or used to increase the load carrying capacity of the vehicle;
 - (c) by the revocation of clause (f) and the substitution of the following:
 - (f) "axle group" means a single axle, a tandem axle group, a tandem equivalent axle, a tridem axle group, a tridem equivalent axle, or a self-steering quad axle;
 - (d) in clause (h), by the addition of the word "extreme" after the words "the centers of";
 - (e) in clause (ao), by the deletion of the words ", including cargo, to the rearmost part of the vehicle or combination of vehicles, including cargo" and the substitution of the words "to the rearmost part of the vehicle or combination of vehicles, including cargo, exclusive of any extension in the distance caused by an aerodynamic device at the rear";

- (f) in clause (ar), by the addition of the words ", exclusive of any extension in the distance caused by an aerodynamic device at the rear" after the words "of the cargo";
- (g) by the addition of the following after clause (as):
- (as.1) "self-steering quad axle" means an axle group composed of a self-steering axle in front of and pneumatically connected to a tridem axle:
- (as.2) "semi-trailer" means a vehicle of the trailer type so designed and used in conjunction with a motor vehicle that some part of its own weight and that of its own load rests upon or is carried by another vehicle;
- (h) in clause (bb), by the deletion of the words "the overall width of an axle across the outside faces of the tires" and the substitution of the words "the width of an axle across the outside faces of the tires measured at any point above the lowest point of the rim".
- 2. Section 2 of the regulations is amended by the revocation of subsection (3) and the substitution of the following:

Maximum allowable weight

- (3) A person operating or causing to be operated a vehicle shall ensure the maximum allowable weight for an axle that may be carried by a vehicle or combination of vehicles on a highway or a portion of a highway does not exceed the least of
 - (a) the sum of the axle group weights computed by multiplying 10 kg/mm of the tire width for each tire installed on the wheels of the axle;
 - (b) the gross axle weight rating;
 - (c) the tire load weight rating multiplied by the number of tires on the axle;
 - (d) 9,100 kg, in the case of an axle equipped with two tires, other than a steering axle, that has tire widths of 445 mm or greater;
 - (e) 9,100 kg, in the case of an axle equipped with four tires;
 - (f) 9,100 kg, in the case of an axle equipped with two tires that is a steering axle, that has tire widths of 445 mm or greater; and
 - (g) 6,000 kg, in the case of an axle equipped with two tires, other than a steering axle, that has tire widths less than 445 mm.
- 3. Clause 6(4)(b) of the regulations is amended by the deletion of the words "the peace officer may".

4. Section 9 of the regulations is amended by the addition of the following after subsection (2):

Maximum dimension limits

- (3) If a vehicle does not match the allowable dimension limits for a vehicle of any category described in Schedule 4 conforming to the applicable diagram in that Schedule, the following maximum dimension limits apply in respect of the vehicle:
 - (a) the vehicle width shall not exceed 2.60 m;
 - (b) the vehicle height shall not exceed 4.15 m;
 - (c) if the vehicle is a single vehicle, its maximum length shall not exceed 12.5 m;
 - (d) if the vehicle is a vehicle combination, the combined length of the vehicle combination shall not exceed 27.5 m.

Exempt items when determining width

- (4) In determining a vehicle's overall width for the purposes of clause (3)(a) and of any category described in Schedule 4 conforming to the applicable diagram in that Schedule, the following shall not be taken into account:
 - (a) one or more side mirrors that do not extend more than 30 cm on each side of the vehicle or combination of vehicles beyond the overall width of the vehicle permitted by clause (3)(a);
 - (b) load securement devices that do not extend more than 10 cm beyond the overall width of the vehicle or combination of vehicles permitted by clause (3)(a);
 - (c) lights and reflectors that extend beyond the widest part of the vehicle or combination of vehicles.

Exempt items when determining height

(5) Antennas, aerodynamic devices or other attachments that extend above a vehicle shall not be considered in determining the height of the vehicle for the purposes of clause (3)(b) and of any category described in Schedule 4 conforming to the applicable diagram in that Schedule.

Exempt items when determining length

- (6) An aerodynamic device installed at the rear of a straight truck, full trailer or semi-trailer shall not be considered in determining the length of a vehicle or combination of vehicles for the purposes of clauses (3)(c) and (d), respectively, and of any category described in Schedule 4 conforming to the applicable diagram in that Schedule, if
 - (a) any portion of the device more than 1.9 m above the ground does not extend more than 1.52 m beyond the rear of the vehicle;
 - (b) any portion of the device within 1.9 m of the ground does not extend more than 0.305 m beyond the rear of the vehicle; and

(c) the aerodynamic device is not designed or used to carry cargo.

Dimensions of load part of vehicle

(7) In determining the dimensions of a vehicle, the dimensions of any load on the vehicle shall be considered as a part of the vehicle.

Exception

- (8) A person may operate or cause to be operated a vehicle having dimensions that exceed the maximum dimension limits set out in subsection (3) if that person has been granted a permit under section 46 of the Act.
- 5. Subsection 10(2) of the regulations is amended by the deletion of the word "25" and the substitution of the words "27.5".
- 6. (1) Schedule 4 to the regulations is amended in "Category 1: Tractor Semi-trailer" by the revocation of the Table "Maximum Semi-trailer Wheelbases" and the substitution of the following:

EXPLANATORY NOTES

SECTION 1 amends the definition section at section 1 of the *Roads Act* Vehicle Weights and Dimensions Regulations (EC01/02). New definitions are added to the provision and amendments to existing definitions are being made to update terms used in the regulations.

SECTION 2 revokes subsection 2(3) of the regulations and substitutes a new subsection 2(3). This provision sets out the maximum allowable weight for an axle that may be carried by a vehicle or combination of vehicles on a highway.

SECTION 3 amends clause 6(4)(b) of the regulations to correct a minor clerical error.

SECTION 4 amends section 9 of the regulations to set out maximum dimension limits for vehicles that are not contained in the categories of vehicles described in Schedule 4 to the regulations. The provisions also set out what is not included in determining the width, height and length of a vehicle of any category described in Schedule 4. An exception to maximum dimension limits is added to the provision.

SECTION 5 amends subsection 10(2) of the regulations to extend the length of A, B and C train doubles that are 23 to 25 metres to the newly permitted maximum of 23 to 27.5 metres in length.

SECTION 6 amends Schedule 4 to the regulations to add two Tables to the Schedule. Three new categories of vehicles are added to Schedule 4. A number of categories of vehicles set out in Schedule 4 are either being amended or revoked and substituted to reflect allowable dimension limits and weight limits for the various categories of vehicles set out in the Schedule.

SECTION 7 provides for the commencement of the regulations.
