GENERAL REGULATIONS
AMENDMENT

- (t) Prince Edward Island Public Service Commission;
- (u) Workers Compensation Board of Prince Edward Island.

2. The Schedule to the regulations is revoked and the Schedule as set out in the Schedule to these regulations is substituted.

3. These regulations come into force on December 30, 2017.
